CEO Adele Reid took questions on the draft 2022 Year End Financial Report and Statements presented to the Board, clarifying revenue and expense variances and the recommended allocation of the final positive variance into KTPL's reserve accounts. Ms. Reid emphasized that the Statements are considered drafts until the completion of the 2022 audit. The next step will be the submission of the 2022 Audited Statement to the Canada Revenue Agency via the Registered Charity Organization Return, which is required to maintain the ability to provide tax-receipts for donations.

## 10.4 CEO Report (Verbal)

Ms. Reid highlighted an article in the March 30<sup>th</sup> edition of the King Sentinel about the Township's Council approval to start work on what was referred to as "re-imagination" of the municipal presence in Nobleton, including the relocation of the Nobleton branch to a municipal campus. In anticipation of this project, the consultants who prepared KTPL's 2014 Master Facilities Plan were retained to update the Nobleton section to reflect the new population growth forecast as released by the Region of York in 2022. This update will provide insight on size, functional spaces and amenities that will serve the forecast growth over a long-term horizon. The consultant, along with the Director of Community Services will be at the May meeting to present the update and address Board questions.

Ms. Reid advised that 2022 financial audit process was near complete. The Library returned to a stand-alone audit after a few years of being consolidated into the Township's audit, and consequently, it included both 2021 and 2022 activity to enable the auditors to provide an opinion statement on the state of the Library's financials. \$5,000 was built into the 2023 budget to cover the cost. A legal requirement for public entities, the purpose of the audit is to provide assurance that financial statements are presented accurately and in conformity with generally accepted accounting principles. Ms. Reid has discussed concerns of how the audit was conducted, primarily the reliance on scanned documentation and the resulting disruption to staff, with the Township's Director of Finance.

Feedback about the current hours of operation versus pre-pandemic continues to come in. Despite being in the form of complaints, staff regard this feedback as an indication that the community continues to value and seek library services. With recruitment filling the vacancies, as well as organizational updates, staff plan for an additional weekday and Sundays at King City in the fall.
